Bingenheim: executed for witchcraft in 1652

- 1. Hanß Rau from Berstadt
- 2. "The swineherd's boy from Bisse, who was burned along with Johann Waasen's
- wife, who was the 'Head Witch' of the witches of Echzell [north of Bingenheim]"
- 3. Johann Schultheiß's wife, Gersten
- 4. Conrad Heusen's daughter, "burnt"

5. "Matthäus Schütz's wife from Geltenau was burnt alive, for having hexed her two husbands, her brother and her brother-in-law"

6. "The Jew, Löw³, from Bisse, was burnt alive"

Oppenrod: executed for witchcraft in 1655

1. Eva Eisermann, burned in September 1655

Reiskirchen and Grossen-Buseck: executed for witchcraft in 1655-1656

- 1. Unnamed woman (who accused the women named below as well as Pfarrer Johann Steindecker, whom two of my ancestors, Nürnberger the shepherd and Johannes Lenhardt, schoolmaster, also implicated)
- 2. Dorothea Samm, burned
- 3. Margaretha Fritz (my ancestor), burned
- 4. The miller's wife, burned

Another of my ancestors, Catharina Bauernfeind, wife of Church Treasurer Bauernfeind, was accused by Dorothea Samm but was not prosecuted.

Burkhardsfelden, witch trial 1672-1674 (not executed)

1. Else Schmidt, aka die Schulelse. She was acquitted by the law faculty from the University of Mainz, after enduring two years of torture.

Beuern, 1660s:

1. Matthäus Stein, Kirchensenior, was accused of being a Hexenmeister but not prosecuted. His wife, Christina, was the natural daughter of Imperial Lieutenant Helwig von Buseck, who died at Wittstock in 1636. They were both conducting a lawsuit against her paternal family for recognition of her birth as legitimate and for her share of her late father's family inheritance. They are my 12x great-grandparents.
